The guard band is equal to the expanded measurement uncertainty with a 95% coverage probability(k=2), k=10, where k=10 is the Probability of False Accept and the Probability of False Reject of the decision rule are 2.5%.

For Upper Tolerance Limit (T_U):

Pass - when the measurement result is below T_U - U_{95}

Fail - when the measurement result is above T_U+U_{95}

Inconclusive - when the measurement result is falling in guard band [Tu-U95, Tu+U95]


