陈骁骅博士现任浙江大学国际联合商学院助理教授,博士毕业于 剑桥大学经济系。主要研究领域是宏观金融,经济周期,战略发展。



**魏彬如** ZIBS 助理教授

魏彬如博士毕业于剑桥大学,现任浙江大学国际联合商学院助理教授,曾在英国六星商学院兰卡斯特大学商学院担任教职。主要研究领域为宏观经济,空间经济和碳经济等,具体研究课题包括基础设施建设对城市经济发展的解构与评估,新能源产业与绿色经济研究,以及碳经济政策的量化分析等。研究方法为机器学习,计量分析与基于代理的经济学建模等。



李 超 ZIBS海纳研究员


**万峰** ZIBS 助理教授

José Manuel Martínez Sierra


General Director and Provost of the UPF Barcelona School of Management

He is a Doctor of Business Administration at Fundação Getulio Vargas, Brasil. As Associate Dean at FDC for 14 years, Antonio Batista played an active role in several areas of the School. He was responsible for Executive Education comprising Customized, Open enrollment and Degrees Programs. He directed different partnerships and networks with large corporations, family businesses, small and medium sized companies with the purpose of researching, training and consulting in the management field.

She also completed a visiting scholar program at Cambridge Judge Business School, University of Cambridge, United Kingdom. For her undergraduate studies, she majored in Accounting at the School of Management, Zhejiang University, earning a Bachelor's degree in Management. During her academic tenure, she published numerous papers in SSCI journals, core journals, and contributed to the writing of textbooks such as "Internet Finance: Theory and Practice." She played a key role in three key projects for the Financial Technology Committee of the People's Bank of China and one key project for the Zhejiang Provincial Government. Additionally, she participated in the formulation of two national financial industry standards.

She has led or participated in over 30 collaborative projects with entities such as the People's Bank of China, the Financial Bureau of Zhejiang Province, the Financial Bureau of Beijing Municipality, the Beijing Financial Technology Industry Alliance, Alibaba, Ant Group, University of Cambridge, Asian Development Bank, German International Cooperation Agency, and the South African National Research Council. These projects encompass government initiatives, corporate endeavors, and international collaborations, resulting in the production of over 50 reports and research papers. Furthermore, her research achievements have received endorsements from several provincial and ministerial-level leaders.

Dr. Jia Jia Lim is an Assistant Professor of Supply Chain Management & Sustainability at ZIBS. She uses qualitative and quantitative methods to examine the intersections between new technologies and collaboration relationship between firms for sustainability. Within the area of supply chain management and sustainability, she has published in International Journal of Operations & Production Management, Industrial Marketing Management, Journal of Business Research and International Journal of Production Economics. She also served as editorial review board member at Journal of Supply Chain Management and reviewer at Industrial Management and Data Systems.





Godofredo Ramizo Jr.

Presidential Postdoctoral Fellow and Principal Investigator of Nanyang Business School (NBS), Nanyang Technological University Dr. Godofredo Ramizo Jr., a PhD holder in digital technologies from the University of Oxford, is a leading expert in the digital economy, AI, and algorithmic systems. As a Nanyang Presidential Fellow at NTU, he manages a SGD 200,000 grant, steering international AI transformation and user behavior research. With publications in global journals and presentations at key conferences, he's a sought-after speaker on digital tech and AI implications for businesses. His rich background includes impactful roles in Oxford research groups, Meta (formerly Facebook), and contributions to innovative technology products for Fortune500 companies.
